January 20, 2026	Deadline to submit questions for the “Frequently Asked Questions (FAQ)” document.
January 27, 2026	United Way will upload FAQ document to website.
February 12, 2026	Panel Chair Volunteer Training
February 23, 2026	5:00 pm. Deadline to submit applications for a completion audit (applications will be audited for completion only -aka no content will be reviewed). *NOTE: Organizations/Programs are not required to submit application for completion audit*
February 27, 2026	Panel Member Volunteer Training
February 27, 2026	All Community Investment Grant Applications due to UWSWOK office by 5:00pm (Late and/or incomplete applications will not be considered for funding review.)
March 3, 2026	Grant applications open up for Panel Review
March 9- April 3, 2026	Partner Site Visits
April 6-10, 2026	Panels complete post-visit assessments and compile feedback from site visits
April 13, 2026	Panel Recommendations Due
April 16, 2026	Panel Chair Meeting
April 22, 2026	UWSWOK Board Meeting

Formatting Instructions and Requirements

- **Submit completed application** provided to you by UWSWOK including each program for which you are applying for funding to the UWSWOK office no later than 5PM on February 27, 2026.
- ALL uploaded and saved documents on the website application MUST HAVE SIGNATURES.
- To take part in the Completion Audit (see page 2 for due date) a complete application must be submitted. No email applications will be accepted.
- YTD balance sheet and profit/loss statement are to be uploaded as 1 document.
- Before submitting your application, please review it to ensure that all requested items are included. After the deadline you may not make any changes to your submitted grant application.
- Do NOT add any additional information other than those specifically requested.
- **Proposals missing any required information will be marked "INCOMPLETE" and will not be considered for funding.**
